

**ROAD TRAFFIC REGULATION ACT 1984**

**THE COUNTY OF DEVON (TEMPORARY RESTRICTION) (LYME STREET - SOUTH STREET,  
AXMINSTER) ORDER 2020**

**TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING & SUSPENSION  
OF ONE WAY**

**NOTICE** is hereby given that Devon County Council has made the above titled order.

From **THURSDAY 2 JANUARY 2020**  
for a maximum of 18 months

Anticipated Finish **WEDNESDAY 26 FEBRUARY 2020**

No person shall cause or permit any vehicle to wait, load or unload during specified periods when traffic cones/signs are in place on any of the lengths of Affected Roads.

Roads affected –  
**SOUTH STREET, AXMINSTER.**

From **18:30** on **Friday 7th February** until **Wednesday 26th February** (both dates inclusive).

The one-way system on the Affected Roads will be suspended when temporary traffic signs are in place.

Roads affected –  
**SOUTH STREET, AXMINSTER.**

No person shall cause or permit any vehicle to proceed or wait on the sections of Affected Roads.

Roads affected -  
**LYME STREET, AXMINSTER** - from **18:30** on **Friday 7th February** until **07:00** on **Wednesday 12th February** (both dates inclusive).

**SOUTH STREET, AXMINSTER** - from **18:30** on **Friday 7th February** until **Wednesday 26th February** (both dates inclusive).

The alternative, signed, route for vehicles will be via - **MUSBURY ROAD - A358 KING EDWARD ROAD - A358 WEST STREET - B3261 LYME STREET - LYME ROAD - COOMBE LANE (WHEN LYME STREET IS OPEN)**

**MUSBURY ROAD - A358 KING EDWARD ROAD - A358 WEST STREET - VICTORIA PLACE - CHARD STREET - STONEY LANE - LYME ROAD - COOMBE LANE (WHEN LYME STREET IS CLOSED) - EAST BOUND**

**LYME ROAD, STONEY LANE, A358 CHARD ROAD & B3261 GEORGE STREET - WEST BOUND**

This temporary restriction is considered necessary to enable -  
**REPLACE 176M OF OLD METALLIC GAS MAINS WITH NEW PLASTIC MAINS AND RENEW/TRANSFER APPROX. 49 SERVICE PIPES TO ADJACENT PREMISES.**
