- ix) To consider the level of grant subsidy payable by the Town Council to the Guildhall Management Committee in the forthcoming financial year (2023-24) as per the terms of the GMC Scheme Deed and the financial framework under which such subsidy is paid.
- x) To consider any potential risks to the Council in maintaining the current relationship with the GMC or such risks as may be relevant should changes to that relationship arise.
- xi) To consider and, if thought fit, to resolve upon an appropriate recommendation to the GMC setting out Council's views on the future operation and long-term sustainability of the Guildhall as a community amenity and facility for Axminster and the surrounding parishes.
