AXMINSTER TOWN COUNCIL CANNOT SUPPORT THIS APPLICATION FOR THE FOLLOWING REASONS:

- 1. THERE APPEARS TO BE A DECREASE IN THE PROVISION OF DISABLED PARKING WHICH IS UNACCEPTABLE IN A HOSPITAL SITE.
- 2. THERE IS A CONFLICT IN THE INFORMATION SET OUT IN SECTION 9 OF THE APPLICATION FORM WHICH STATES THAT THE NUMBER OF PARKING SPACES WILL BE REDUCED BY FOUR AND THAT IN THE "PROPOSED DEVELOPMENT" SECTION OF THE TECHNICAL REPORT WHICH STATES "NOTWITHSTANDING THE 23 CAR PARKING SPACES SITUATED ADJACENT TO THE SCOTT ROWE BUILDING, THE DEVELOPMENT PROPOSALS COMPRISE THE RECONFIGURATION OF THE ON-SITE CAR PARK TO ACCOMMODATE A TOTAL OF 71 SPACES (NET INCREASE OF 14) AS WELL AS THE CREATION OF A NEW ACCESS TO SERVE THE SCOTT ROWE BUILDING OFF THE EASTERN SIDE OF THE INTERNAL ROAD OF AXMINSTER HOSPITAL. DRAWING 20036/002 REVISION C SHOWS THE PROPOSED ACCESS AND PARKING ARRANGEMENTS."
