#### 3. Minutes of the last meeting:

Minutes of the last Annual Parish Meeting held on Monday 27<sup>th</sup> March 2023 were considered and noted. Cllr. Farrow proposed the adoption of the minutes from the chair. These were resolved by the majority of those present by way of a show of hands. Cllr. Farrow signed the minutes as a true and accurate record of the meeting.

## 5&6. To receive joint presentation from the EA and EDDC on matters relating to flooding, and emergency planning.

Chair thanked both speakers for attending in the evening. Representations from those present: Concerns over future anticipated flood events at Stoney Bridge from residents. Criticism of EA/EDDC/Town Council to prevent flood damage to properties in that area. Suggestions/requests that a parish emergency plan/protocol (PEP) be created by the Town Council Agreement from Chair of the Town Council that issue will be added to FULL Town Council agenda on 11/3/24. Offers of help from EDDC and EA to support creation of a PEP with advice, resource and funding.
